In the matter of the Applicant's request for review of Minister's decision # 19-00805 which reviewed a Notice of Violation # 4971-19-0373 with a penalty of \$800 issued on February 22, 2019 for breaching s. 40 of the *Health of Animals Regulation*.

ORDER ARISING FROM THE CASE MANAGEMENT CONFERENCE CALL HELD ON DECEMBER 9, 2020

1. BACKGROUND TO THE CURRENT ORDER

[1] The Applicant was issued a Notice of Violation (NOV) and assessed a penalty of \$800 arising from the alleged import of chicken without the requisite import permit. The Minister of Public Safety and Emergency Preparedness confirmed the NOV and penalty after conducting a review. The Tribunal received a request for a review of the Minister's decision from the Applicant on June 7, 2019.

[2] The Canada Agricultural Review Tribunal (Tribunal) determined that Mr. Zerihun's application was admissible on August 8, 2019 and the decision was made to proceed by oral hearing.

[3] In the spring of 2020, The Tribunal elected to suspend all hearings in response to the global COVID-19 pandemic. The oral hearings resumed in November 2020.

[4] Given the current public health guidelines to avoid unnecessary travel and in-person gatherings, the Tribunal is exercising its authority granted to it under s. 20 of the *Rules of the Review Tribunal (Canada Agricultural Review Tribunal)* to conduct the hearing by videoconference. The Tribunal will be using the Zoom platform.

[5] On December 9, 2020, the Tribunal held a Case Management Conference Call (CMCC) to establish the parameters and date for an expeditious and fair hearing.

[6] During the CMCC, the parties have agreed that:

- a. The hearing will last half of a day and will be held on January 21, 2021.
- b. Neither party intends to call any witnesses.
- c. The representative for the Respondent, Ms. Valerie Laroque, will prepare a proposed Agreed Statement of Fact and provide it to the Applicant by January 11, 2021 for his consideration.
- d. Neither party intends to submit evidence beyond the Agency Report.
- e. The Respondent will provide a submission brief in PDF form to the Tribunal no later than January 14, 2021.

2. ORDERS

[7] I **ORDER** that the oral hearing be held via videoconference on January 21, 2021 commencing at 13:00 pm (EST).

[8] I **ORDER** that Parties confirm whether the parties intend to submit an Agreed Statement of Facts by January 14, 2021.

[9] I **ORDER** that the Respondent file their submission brief no later than January 14, 2021
